APPLICATION FOR TRANSFER INTO THE SERPENT RIVER FIRST NATION BAND OF OJIBWAYS

The Serpent River First Nation adopted a Membership Code on the 27th day of June 1987. The membership code was revised on February 14, 1994. This Membership Code is the governing document when applying for membership transfer into the Serpent River First Nation. There are a number of important procedures to follow as outlined below:

- 1. The membership transfer application must be filled out thoroughly with no empty blanks. Be sure to include the band numbers of parents and grand-parents.
- The sponsor of your membership transfer application is to be ordinarily resident and a member of the 2. Serpent River First Nation. The sponsor must sign Part F and be willing to speak on your behalf in case there are any concerns.
- 3. There are three (3) character reference letters required. These letters are to be from Serpent River First Nation members (excluding immediate family). One of the letters must be from your sponsor. You may have the letters mailed or faxed to the membership registrar. (Transfer applicants require a letter of request to transfer and a letter from the Band they are transferring from to indicate their membership).
- There is a Transfer Processing Fee of One Hundred and Fifty dollars (\$150.00) (Chief and Council Motion 4. # 2019-02-11-09), per application, that must be included when submitting an application.
- 5. All information in this application shall be kept confidential, but the Chief and Council may make inquiries of various persons to verify or complete the information.
- 6. Questions, concerns, or information you need to know can be obtained from the Membership Registrar.
- 7. Any applicant who is registered as an Indian (6.2) must have at least two people who are their natural grandparents who are, or are deemed to have been entitled to be registered as Indians under the Indian Act, if deceased.
- 8. Any applicant must be culturally connected with the Serpent River First Nation.
