- Snow Removal Services Extraordinary Circumstances Policy Exemption
- Snow removal and lawn care under the First Nation is made available to those who meet the criteria for those services under the Home and Community Care program. There is an assessment completed with the band member to determine their eligibility. It is a fair and consistent process for all members. In 2022 it was identified the approved policy was not consistently being followed. As a result a decision was made to follow the approved policy to ensure all members were treated fairly and equitably. The list was reviewed with Home and Community Care program staff to ensure members of the Housing and Infrastructure department had a clear understanding of who should be receiving such services. There is no documentation to support why some decisions were made in the past
- There is a list of home addresses that are approved for snow removal and lawn care and staff are to adhere to that list with the exception of when there are extraordinary snowfalls of which we have attempted as an administration to assist members without the ability to do snow removal of that magnitude. Lawn care is not an issue.
- There are four addresses that are determined to be extraordinary "driveways" due to the location of their homes:

511 Highway 17

- 183 Walkhouse Bay Road
- 64 Village Road West
- Camp Lake Road (2 Addresses)
- These "driveways" have either a significant grade to them or they are extremely long in length. They would be cost prohibitive for those members to maintain the snow removal. Infrastructure staff have
