Position Summary:

The Child & Youth Mental Wellness Worker is responsible to provide mental health counselling services to the children and youth of Serpent River First Nation.

DUTIES:

The Youth Counsellor shall, in every aspect of their position:

- Promote the Serpent River First Nations Vision and Mission Statements
- Uphold the ethics of their positions, as it relates to the Social Worker Code of Ethics and the Community Wellness Team's values and principles
- Work with the client in the identification of a plan of care
- Work with families of client's seeking services
- Make referrals for those individuals who are outside the scope of practice
- Ensure effective coordination of case management systems while ensure protection of client information as per policies.
- Work in cooperation with Community Wellness Team to facilitate program direction and goals
- Participate in case conferencing with other service providers to ensure and effective outcome for the client.
- Networking with external agencies that have an impact or could enhance client care or general mental health programming.
- Complete and submit all relevant reports (monthly, training, newsletter, etc.) as directed by Supervisor
- Maintain client files
- Participate in regular clinical supervision meetings, as per the Fee for Services agreement between SRFN and the Elliot Lake Family Life Center.

QUALIFICATIONS:

The Youth Counsellor shall possess:

- University Degree or College Diploma in Social Services
- Minimum of two years experienced in the clinical counselling setting
- Valid Ontario Driver's License and willing to travel
- First Aid and CPR certification
- Must provide a clear criminal reference check

- Knowledge of the Seven Grandfather Teachings
- Ability to understand Ojibwe is considered a strong asset
